Dear Friends and Supporters,

The year 2010–2011 (March ending) was our third for our children’s home, Karunya Mane. During the year, we welcomed a few new faces and experienced the departure of a few of our older children. Overall, we improved on the quality of the education we provide as we enrolled a few more promising little ones into an excellent private school.

- Our child count at Karunya Mane (“KM”) went from 43 as of March 2010 to 50 as of March 2011.
- Saw continuing behavioral and health improvements in the kids at KM, including excelling in school and becoming more self-disciplined.
- Maintained Project Food and More (“PFM”) at 53 kids as of March 2010; PFM provides monthly support to destitute children orphaned by HIV/AIDS and other diseases and now supports single, HIV+ women abandoned by their families.
- Continued to support women who work and live on the streets, as they have become more self-reliant and independent.

At Karunya Mane, our children are getting older, as kids do. We continue to work with them on their self-discipline and self-confidence, their studies in school, how they treat others, and taking more ownership of their living environment. We continue to provide our kids with everything they would receive in a normal home environment and maintain quality in the following areas:


- Meals – we use quality ingredients, such as fresh vegetables and lots of lentils and other grains in the sambar (curry), serve ragi mudde (millet balls) frequently, use fibrous and nutritious red rice along with white rice, and monitor their sugar intake in the form of cookies and sweets;
- Continue to use quality doctors, dentists, and hospitals, and engaged the services of an ophthalmologist this year for our kids who need glasses;
- Enrolled five more of our brightest children (in addition to the two continuing children) into St. Francis School, an elite private school in the area typically attended only by middle- and upper-middle class children; and
- Created a children’s committee (one for the boys and one for the girls) each with three “leaders” elected by their peers, to give the kids a sense of ownership of the home and more of a say in their day-to-day living.

Our financial support for our street moms in our Street People Program (“SPP”) continues, and the mothers, our street moms continue to be quite independent and enjoy their visits with their kids at KM. Our street moms continue to be our best source for other destitute children and adults who seek assistance.

Project Food and More, in its third year, helps kids orphaned by HIV/AIDS. PFM provides qualified kids with a monthly care package containing basic necessities and nutritional supplements, and a bit of cash. As of March 2011, we supported 53 children and their guardians in this program.

We continue to use the support that we receive from you efficiently and sensibly, as shown below.

In 2010–2011, 91% of our expenditures went directly to the people we help.

In this annual report, we highlight the newcomers to Karunya Mane during the past year, as well as their family backgrounds and stories. They are all brave children who endured very difficult family and home environments, and are eager to get on with their lives.

As always, we thank our supporters and child sponsors, who make it possible for our kids to enjoy their childhood and grow up to be responsible adults. Unlike the years when they lived on the street and in the slums, our kids continue to enjoy **just being kids**.

Suma (lower right, age 12), Manjula (left, age 11), and Renuka (top right, age 8), came to us in June 2010 (along with their little brother Manu) after their mom died. They lived with their mom in a slum area, and then on the streets of Mysore. We took them in, as they weren't able to live with their stepdad since he has another family to care for. For a while, the girls attended a government school that had four teachers for grades 1 through 7. They now study well at Deepa School and get daily tutoring at Karunya Mane.

About us

Akhandha Seva for International Shanti, also known as Operation Shanti, is a charitable organization with programs in Mysore, India. We serve the poorest children and their families living on the streets of Mysore or in abject poverty in slums.

Our vision...

Operation Shanti envisions a world in which the poor are given the opportunity to reach their full potential in life. We endeavor to spread peace, goodwill, and hope throughout our world by helping the poorest and neediest gain status and their rightful place in their societies. Often, the poor are robbed of their human rights, are discarded, treated inhumanely, and ignored. The ultimate goal of our work is to give the poor back their rights as human beings.

Our mission...

Our mission is to directly improve the lives of exploited, at-risk, destitute children and the forgotten, suffering elderly, enabling them to become “beacons of light” and share the same gifts of peace, goodwill, and generosity with others for the rest of their lifetimes.

We help the poorest and neediest children and elderly, and the forgotten destitute, with the basic human needs: food, shelter, medical services, and educational assistance. As we believe that every human can and should stand on his/her own, we are there to help the destitute begin to help themselves.

Our programs


We have been working directly on the streets of Mysore with street children and their families since 2005. Our programs include our Street People Program, Karunya Mane (our shelter for destitute kids), and Project Food and More, which supports destitute children orphaned by HIV/AIDS.

KARUNYA MANE

Karunya Mane (“House of Compassion for the Poor”) opened on February 10, 2008. Karunya Mane provides a healthy and safe home environment for the poorest street and slum children who have nowhere else to go.

About 18% of our kids at Karunya Mane have no parents, another 40% have one parent—usually a mother—and the rest of the kids (42%) have a mom and a dad who are destitute and cannot properly care for their children.

At Karunya Mane, we provide our children with everything that a child in a middle-class home environment receives—proper adult supervision, a bed, clothing and footwear, good and clean food, filtered water, education and after-school tutoring, discipline and patience, medical care, opportunities to socialize, extracurricular activities, and lots of fun and hugs.



Manu, age 5, came to us in June 2010 after his mom died. He lived with his mom and three sisters on the streets of Mysore after being kicked out of their house in a slum area. Manu is a very good boy, well behaved, sweet, and quiet. Manu attended school this year at St. Francis School, an elite English medium school.

As of March 31, 2011, we housed an equal number of boys (25) and girls (25) in separate quarters, with common eating and study areas. We take in girls because they are the most vulnerable in this society. We take in boys because, without proper guidance, they are likely to grow up to be wife-beaters and alcoholics—the problem that many of our street and slum moms face with their own husbands.

STREET PEOPLE PROGRAM

Our Street People Program is a significant resource for destitute children and women living on the streets. These individuals often have nowhere else to turn for help and an insufficient number of charitable organizations work directly on the streets.

Karunya Mane now houses most of the children who have come through our Street People Program since 2005. The program continues to support their mothers who work on the street, and other destitute women and men with basic necessities, such as food, shelter, medical assistance, and educational opportunities.

Our core group of “street moms”—the women who once lived on the street and now live in houses that we help them rent—remain a loyal and excellent resource for us. These women assist us in helping other destitutes living on the streets and refer other street children to Karunya Mane. Since most of the kids of our “street moms” live at Karunya Mane, they have seen the positive changes in the behavior of their kids, and are very supportive of our work.

Helping street people is not easy. For various reasons, many do not trust others who try to help them, and many are set in their ways of living on the street and do not want to or cannot change. We are there for those who want a better life and who want to give their kids a better life.

PROJECT FOOD AND MORE

In September 2008, we started Project Food and More (PFM), an effort to assist children from the poorest backgrounds who have lost one or both parents to HIV/AIDS. These children live with another family member, typically a grandmother who is also destitute, and now faces the challenge of having to feed another mouth (or two).

Qualifying for PFM requires that a child has lost one or both parents (or if there are two parents, both are unable to work given their health issues), and that the child’s current guardian is very poor and struggles to feed him or her. We conduct due diligence visits to the living conditions of potential PFM candidates to ascertain that a child and his or her caretakers are indeed poor.

We provide a monthly care package for each PFM child. This care packages includes:

- Nutritional items such as lentils, protein powder, and healthy biscuits;
- Hygiene-related items such as mosquito repellent, bath and laundry soap, and toothpaste; and
- A small stipend.

The guardians use the stipend to pay rent on their houses or shacks (typically around Rs.200/US\$6 to Rs.800/US\$8 per month) and to purchase additional food. Sometimes, they are able to save a little for the child's future.

We work with an HIV clinic in Mysore that has an outstanding pediatric HIV program. They refer the poorest children registered at their clinic for possible enrollment in our program.

PFM has been recently expanded to assist HIV+ women in the same way. A woman must meet certain criteria: has been abandoned by her husband and family (usually the in-laws), may or may not be a single mother caring for her children alone, and has little or nothing in terms of personal resources and the means to earn a living.

The year in review

Street People Program

During this, our fifth year of our Street People Program, we continued our work directly on the streets of Mysore, with assistance for 10 to 20* children, mothers, and grannies.

Our program has changed from prior years, as most of the street children with whom we worked are now at our shelter, Karunya Mane. We continue to support their mothers, who now live in houses that we help rent for them, and who work on the street selling flowers and vegetables. We provide them with a weekly stipend and medical assistance and, in return, these women have become a very useful resource for us in referring other poor women and kids to our programs.




Surya has been with us for three years. He used to play on the sidewalk while his mom begged on the city streets. Surya now attends St. Francis School, an elite private school in the area, and was #1 in his class last year. Surya is the ideal child, sweet, kind, quiet, very well behaved, and just so special.

Karunya Mane

This year, we saw continued progress and improvement in the kids at Karunya Mane in all areas of their lives. Karunya Mane ended the 2010–2011 year with 50 children.

Karunya Mane employs five permanent staff members, eight after-school tutors, two watchmen, and utilizes volunteers where needed. The tutors work with our kids for an hour and a half to two hours every day after school, and our staff are dedicated to the well being of our children.


As in the past, the kids showed continued improvement in their grades in school this year. They all received As and Bs in their classes, and their good study habits continue to develop. This year, four additional boys showed great potential in school, and as of June 2011 we had enrolled them in an English-medium private school (to join our two children returning to the same school), to give them a chance to excel.



Prajwal, age 10, came to Karunya Mane in 2010. His mom used to work for us as a house-keeper before falling ill. After an extended illness, she passed away. Prajwal's dad abandoned the family before Prajwal was born, and his relatives in the nearby village didn't want to take care of him after mom died, so he's been staying at Karunya Mane. Prajwal is an excellent student and an all-around good kid.

Project Food and More

Project Food and More (PFM), started in September 2008 in response to a visible need to assist destitute children who have been orphaned by HIV/AIDS, has grown from 23 kids to 31 kids in March 2009 and 51 kids as of March 2010.



We have stabilized the number of children at 53 for the past year. Most of the children now live with a grandmother, an uncle or an aunt, or a remaining living parent—often a positive single mother. These guardians must now feed and care for an extra mouth or two, while already very poor themselves.

We conduct due diligence through interviews and house visits to determine whether a child and his or her guardian are indeed poor. PFM kids and their guardians face many obstacles, including social stigma because of their health conditions.

A few of the mothers and children in this program have been outcast by their own families who have kicked them out of their houses and refuse to acknowledge them.

Many of the fathers who died were truck drivers who brought the virus home after long journeys on the road. They then passed it on to an unsuspecting wife, who then passed it on to her child during childbirth. Uneducated villagers often engage in extramarital relations, unaware of the risks involved. Many single mothers tell us that they had no idea they were positive until their husband passed away, and then someone told them to get tested.

The good news is that the government assistance programs provide free antiretroviral therapy to children and adults who need it. We endeavor to fill in the “holes” by providing nutritional and financial support to those who truly need it.



 - c) The Balance Sheet and the Income and Expenditure Account dealt with by this report are in agreement with the books of accounts.




- d) In our opinion, these accounts have been prepared in compliance with the applicable accounting standards referred to in Section 211 (3C) of the Companies Act, 1956.




